Richard Murphy is a tax accountant, but one who is also a leading researcher on tax justice and how to stop corporations and rich people dodging paying tax.

He founded the Tax Justice Network (funded by Joseph Rowntree Charitable Trust), and is a director of Tax Research LLP - which utilises forensic analysis to examine tax arrangements. Occupation (and why)? Chartered accountant. Because, despite
